Introduction

Target group

This workshop is designed primarily for European Social Fund (ESF) Managing Authorities at both national and regional level.

Description and objectives

In February 2013 the European Commission adopted the Recommendation "Investing in Children-breaking the cycle of disadvantage" (REC) as part of the Social Investment Package. The Recommendation recalls that investment in children is not only a fair but also a cost efficient approach, contributing to long term growth. It invites Member States to step up their efforts and grasp opportunities provided by EU instruments.

The issue is most relevant in Bulgaria: children and families have been particularly hit by the crisis, with about 28.2% of children now at risk of poverty and 46.6% facing material deprivation. In the context of Europe 2020, the EU's growth strategy, the European Commission and the European Council recently called on Bulgaria to "further improve the accessibility and effectiveness of social services and transfers for children (...) step up efforts to improve access to quality inclusive pre-school and school education of disadvantaged children, and implement strictly the rules linking the payment of child allowance to participation in education".

The seminar will discuss ongoing policy developments, such as the National Child Strategy 2008-2018 and the National Strategy for Reducing Poverty and Promoting Social Inclusion 2020. It will discuss lessons from the past and how to move forward in the new programming period 2014-2020.

The 2014 CSRs argue that BG should:

- In order to alleviate poverty, further improve the accessibility and effectiveness of social services and transfers for children and older people.
- Step up efforts to improve access to quality inclusive pre-school and school education of disadvantaged children, in particular Roma, and implement strictly the rules linking the payment of child allowance to participation in education.

ECEC is relatively new topic in the public debate in BG and the seminar will highlight its benefits for the disadvantaged people. ECEC and inclusive education for Roma children as well as the possibility for an income support measures in general, could be other topics. De-institutionalization was already extensively debated and might not bring much added value.
